The agency with primary jurisdiction over masks on cruise ships is actually CDC.

DOT OGC confirmed they have no jurisdiction over cruise ships, and DHS OGC told me the coast guard puts out a bulletin to help enforce the CDC masking order, but all the standards that apply to masking on cruise ships come from the CDC order. So I'm glad to help bring the lawyers from DHS/DOT together, but not sure you need them.
